Petition of Edith H. Snow

Pursuant to due notice the Board of Appeal held a public hearing in the hearing room on the second floor of the Town Hall at 8:10 p.m. on December 7, 1972, on the petition of Edith H. Snow requesting permission to continue to use her premises at 43 Laurel Avenue as a lodging house as provided under Section XXIV-E of the Zoning By-law.

On November 17, 1972, the petitioner filed an application with this Board requesting a hearing and thereafter due notice of the hearing was given by mailing and publication.

The petitioner appeared at the hearing and spoke in support of the petition.

Letters favoring the request were received from Ralph A. and Evelyn M. MacGilvra, 21 Laurel Avenue, Frank S. Perkins, 41 Laurel Avenue and W. Eugene and Kathryn Deal Ferguson, 40 Laurel Avenue.

Statement of Facts

The petitioner seeks permission to continue the present non-conforming use of the above-mentioned property and requested that the permit granted by this Board a year ago be renewed for another year. The petitioner stated that her condition is unchanged from a year ago and she still needs an income from the property in order to meet her family obligations and maintain the property. She has been renting rooms to three students and desires to continue for another year.

Decision

The Board finds that there is still a real need for the requested permit to be granted for another year and that a substantial hardship will result to the petitioner and her family if the requested permit is not granted.

Accordingly, the requested permission is granted under the provisions of Section XXIV of the Zoning By-law allow the petitioner to use her dwelling as a rooming house subject to the following conditions:

1. That not more than three roomers shall occupy the premises in addition to the petitioner and her family.
2. That off-street parking spaces for at least two cars shall be provided; and shall be used by the petitioner and her roomers.

- 3. That a minimum number of cars may be parked on the street, in accordance with all other Town ordinances regulating parking, and that such cars may be parked on the street only during the time the off-street parking spaces are occupied.
- 4. That said permit shall expire one year from this date or in the event of a breach of any of these conditions.
