**2. Morses Pond 2020:** With minimum wage increases, it is necessary to raise pond fees to help offset the increased costs. The proposed 2020 rates are:

Non-Resident Daily = \$15

- **5. PFTF:** Bathrooms and Lighting discussions at the high school stadium are still underway. Bathrooms will begin to take priority over lighting in an effort to complete that project next. A bathroom solution that is affordable and practical may have been found. More to come.

**6. CPC:** Discussion of spending CPC money to use the vendor "Best Bees" to create a bee keeping program took place. The yearly cost of 3 bee hives may be around \$10,000 but the cost was still being determined. The commission wanted to see more accurate number figures before returning to CPC with a request.
