A certain parcel of land with the buildings thereon situated in Wellesley, Norfolk County, Massachusetts, bounded and described as follows:

Beginning at the Northeast corner of the granted premises on the Southerly line of Stearns Road, so-called, at a stone bound, three hundred two and 25/100 (302.25) feet West from Francis Road, and running Southerly by land now or formerly of Albion R. Clapp, two hundred twenty (220) feet to a bound; thence running Westerly by land now or formerly of said Albion R. Clapp, one hundred ninety-seven and 4/10 (197.4) feet to a stone bound; thence running Northerly by land now or formerly of said Albion R. 


