Kelly Uller - is strongly advocating for Field Hockey turf space as Babson and Wellesley are closed  
Amy Munchak – User groups are not just offering in-season sports, but year round programming , which is affecting scheduling of fields.

Ansley Martin – COVID did not affect Soccer #'s too badly. Soccer will do what it can to help and work with Field Hockey to find turf space.

Kelly Uller – Volunteer coach schedules cannot get to fields until 530 pm, does not allow sports to start weekly practices earlier. With Field hockey at 70 plus registrations and do not want to get to no cut sports/close registrations due to lack of field space.

Beth Sullivan Woods – Do we have a list of fall needs vs inventory?

Laurance Stuntz: stated in year's past schedules were worked out amongst user groups.

Chris Howard: Having limited time after 530 pm, in the fall, is difficult without lights. Groups have worked together to find field when light is an issue.

Kelly Uller –Looking for any turf as long as groups could the High School practice/game schedule.

Amy Munchak – Not only is space an issue, but also a safety issue when multiple sports are using fields at the same time, like lacrosse and infield for example.

Kelly Uller – Allowing for stadium lights will solve an immediate need for practice times.

Brandon Schmitt stated that concerns from the neighbors is introducing substantial new light with a new activity.

Jay McHale - How much time would be needed by other user groups? We know what School use would be, but need to know what the user group's time would be.

Kelly Uller – Can Field Hockey find at least two days on turf?

Kyle Williams – Athletics is adding football and middle school sports and there is difficulty finding practice space when teams are at away games.

Laurance Stuntz: Asked the user groups to fill out optimization spreadsheet.

Amy Munchak – Most of the user groups are paying large amounts of money to outside facilities, when those funds could be spent in Town.

Michael Bessette – IS there any software to manage this?

Laurance Stuntz – Recreation uses RecTrac that manages facility use.

Laurance Stuntz – This meeting has shown a tremendous demand for a valuable resource.

Jim Miller – 2014 DPW report showed that Hunnewell & Sprague complex shows grass fields are at maximum use.

Kelly Uller – Soccer & Field Hockey will work to solve field conflicts. A long-term discussion should address outside costs.
