5. Project Updates

- a. Field Utilization Study
 - i. Laurance Stuntz and Lisa Collins reported that Weston & Sampson continues to work towards their final report, which is expected this fall.
- b. High School Track and Field
 - i. Linda Chow reported that the Project has been in front of Wetlands two more times and after seven meetings, the WPC has voted to approve the conditions allowing for the updated bathrooms, lights, sound, and team room. Key conditions included:
 - 1. Have a baseline habitat evaluation done (complete).
 - 2. See an evaluation repeated bi-annually three times.
 - 3. No more than 100 hours of usage, with a process for expanding if appropriate and as voted by the NRC and WPC
 - 4. Expectation is that Schools will be responsible for tracking usage and for conducting an end of season debrief and for producing a report of usage.
 - ii. DPW are working to finalize plans and design.
 - iii. Should be in a position at the end of the month to finalize the request from the Field Fund for Phase 2a of the project (lights and sound system).
 - iv. Planning to go back to the NRC in the first meeting of September.
- c. Sprague Bathrooms
 - i. Dave Hickey reported that they are still working on plans and with CXT on profiles for the building. The building will go to the Design Review Board as part of the permitting process.

6. General Fields discussion

- a. Field Lining – after a question from Kelly Uller about the process for paying for lines, Tim Bania from DPW explained that:
 - i. The Town pays for lining of high school and middle school fields.

- ii. Youth sports user groups pay for lining either directly to DPW or to a private contractor. DPW bills for materials to create a mini “fund” for groups and then uses that fund until it is gone. Based on Tim’s recollection, \$3,000 used by lacrosse lasted about 2 years.
- b. Ann Williams reported to the group that Reidy Field is being taken offline this fall and being resodded, regraded, and redone, with a new scoreboard to be installed as well. The project work is starting on August 28th.
