WATERCRAFT RENTAL INFORMATION

Rental Hours

10:00am – 4:30pm

Fees

1-person KAYAK (Age 13+) / \$5 per 30 min
2-person KAYAK (Age 13+) / \$10 per 30 min
STAND UP PADDLE BOARD (Age 15+) / \$10 per 30 min

- Renters may only rent watercraft at the beach office.
- Renters must pay rental fees before each rental session. Rental fees are not included in the cost of a seasonal tag or daily beach fee.
- Renters must sign a rental waiver and release agreement before each rental session.
 - Renters under the age of 18 will not be allowed to rent watercraft without parental/guardian acknowledgement of the rental waiver and release agreement.
- Renters must wear a lifejacket with a whistle during the rental session. Lifejackets must be returned to the beach office at the end of the rental session.
- Kayak renters must be at least 13 years of age.
- Stand Up Paddle Board renters must be at least 15 years of age.
- Renters under the age of 18 must pass the Deep-Water swim test before renting watercraft.
- Renters cannot swim-off or stand-on Kayaks or Canoes.
- Renters must stay within sight of the Lifeguards and may not paddle beyond the designated buoys.
 - Renters who paddle beyond the designated buoys will be asked to return to the beach immediately and will not receive a refund.
- Renters must be respectful of private homeowners.
 - Do not beach on private property. Do not cause excessive noise.
- Renters must return to the beach immediately if requested to do so by beach personnel.
- You may not fish off a rented kayak.
- Children under the age of 3 are not permitted to ride within a kayak.

The Town of Wellesley Recreation Department reserves the right to refuse to rent watercraft to persons who violate these rules.

WATERCRAFT RENTAL WAIVER AND RELEASE AGREEMENT

In consideration of the Town of Wellesley allowing my use of the Town-owned watercraft (the "Town Property") do hereby agree to the following:

I agree to waive, release, and forever discharge the Town of Wellesley and its officials, agents, employees, volunteers, and representatives (the "Releasees"), from any and all responsibilities or liabilities for any personal injury or death to myself, including those caused by a negligent act or omission by those set forth above or on their behalf resulting from my use of the Town Property. This Agreement shall be binding on my heirs, personal representatives, next of kin, estate, administrators, and assignees.

I understand that by signing this Agreement, I represent that I understand fully the rules that have been established for my use of the Town Property and I agree to follow such rules for my personal safety and the safety of others. I promise to indemnify, defend, and hold harmless the Releasees against all legal claims and proceedings of any description, kind, or nature arising or resulting from my voluntary use of the Town Property.

I understand that my use of the Town Property is voluntary and that I am free to choose not to use the Town Property. By signing this Agreement, I affirm that I have decided to use the Town Property with full knowledge that the Releasees will not be liable to anyone for personal injury and property damage that I may suffer or cause while participating in these activities.

I further affirm that I have carefully read this Agreement and that I understand its contents. I am aware that this Agreement is governed by Massachusetts law. I acknowledge that I am 18 years of age or older, I am legally competent to sign this Agreement, and I have signed it of my own free will as a document under seal.
